This form of expression of literature and art has the following characteristics: First, objectification. The soliloguy in British and American literature uses the first person to tell the story, which can make the whole literary work subjective, but does not represent the author's subjective consciousness. The characters of the monologue are objectified. Although the ideas may be agreed upon by the cooperator or the archetype of the character itself belongs to the author, it does not change the objectivity of the dramatic monologue. Secondly, dual voice discourse. This feature means that the speaker and the author are separate individuals, but the speaker's voice contains the author's voice. This feature can be found in many British and American literary works of many periods, which not only enables readers to hear the newbie of the speaker, but also can implicitly feel the voice of the author behind [1]. This form of literary expression has a certain concealment, which is different from lyric poetry to directly express the author's feelings. It can make the whole work more artistic effect and provide readers with rich imagination space. Finally, shape the character image. Dramatic soliloquy does not pay attention to the expression of emotion and thought, but mainly shapes the character's personality and external image when describing the story. In the dramatic soliloguy of British and American literature, the most crucial thing is not the inner world of the characters, but the personality changes between the characters' words, so as to cause the psychological changes of readers and present the relatively secret events or reasons. This form of literary writing attaches great importance to the change of psychological activities

For example, the author will inadvertently show part of the image of the characters in the discourse, usually deviating from the content of the self-evaluation, so as to form a dramatic effect, increase the strength of the characterization of the characters, so that readers can have memory points when reading.

2. Formal analysis of dramatic monologue in British and American literature

2.1. resentment poem

This form of expression belongs to the traditional poetic style, which first appeared in ancient Greece. It uses specific characters to express the sad feelings generated by negative emotions such as parting, death and lovelorn. In the literary works of the early 15th century, most of the authors would tell the story of the poet to present their own emotional experience and personality changes [2]. In the Renaissance, with the continuous increase of literary works, there were more and more resentment poems, which not only created a broader space for the development of resentment poems, but also cultivated a large number of outstanding representative poets, such as Milton and Shakespeare, as shown in Table 1 below. In this stage, the author no longer uses historical figures to tell stories and thoughts, but can freely express thoughts and feelings, which not only expands the imagination space of grievance poetry, but also further enrichis the creation content of British and American literature. In the middle of the 18th century, romanticism exerted a certain influence on the creation of resentment poems, which not only added more romantic colors to the poems, but also presented exotic customs, as shown in Table 2 below. In the late 18th century and the early 19th century, the author began to use the narrative role in the use of resentment poetry, although it formed a great difference from the author's identity, but further enhanced the objectivity of literary creation.

2.2. the letter verse

This form of expression is a poetic style developed in Roman times. It mainly uses a third party to express emotional changes, such as the lamentation of fate, the pain of abandonment, and the feeling of missing. During the Renaissance, letter verse was used more widely. For example, the author asks the protagonist to write a letter to her husband to express her confusion, thus showing her confusion about why her husband does not love her. The greatest advantage of an epigraph is that it implies that the reason why the husband doesn't love him is that the main character is too mediocre. In the age of rationality, literary creators pay little attention to the resentful poetry, so this form of expression has been widely used and developed. Pope's Letter from Elosa to Arbella, for example, uses the relationship between religion and human nature to rationally explore issues and express oneself. The poem is also regarded as an important successor to the dramatic monologue in English literature.

2.3. Humorous oral monologue

In fact, since the 1470s, writers have been using spoken language in poetry, a form of literary expression that can both highlight the character changes and attract the attention of readers and audiences. Humorous oral monologue is a unique form of English literature expression, which can not only fully present the inner world of characters, but also show their personality characteristics. Therefore, this form of expression has gradually become the main content of dramatic monologue in the development. After many literary works have been adapted into films, humorous oral monologues have become the main way for audiences to quickly understand the emotional changes of characters. The tone of such discourse is closer to life and contains distinct charm from beginning to end, which adds the unique charm of literary works [3]. Therefore, the dramatic monologue in traditional British and American literary works not only effectively distinguishes the modern literary works, but also enriches the story telling and the expression of the central idea in a certain sense, which has a positive impact on the research and development of modern literature.
